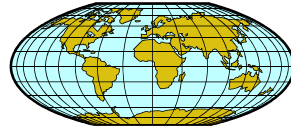

Five Hour CEU Conference Friday, December 7th

Renewal time for private pesticide applicators will be coming up shortly on February 28th, 2013. As a reminder to anyone with a license, private applicators need 15 Continuing Education Units in order to re-certify. Two hours must be in Laws and Regulations and two hours must be in Integrated Pest Management, with the others coming in the General Category.

Anyone needing hours should mark **Friday, December 7th** on their calendar. On this day, the Beef and Forage Committee of Austin County, the Austin County Farm Bureau and the Sealy FFA Chapter will be co-sponsoring a 5 hour CEU course at Four County Auction Center in Industry. Registration will take place at 12:00 p.m., with the program following about 1:00 p.m.

The program topics will include Pesticide Laws and Regulations, The Seven Things Every Beef Producer Should Know, IPM for Pasture Pests, Feral Hog Control and the new Identification Requirements for Cattle. A meal and refreshments will be served following the meeting compliments of Switzer Auction Services, Positive Feed, Pfizer Animal Health, Capital Farm Credit, Tegler Chevrolet & Toyota, Washington County Tractor, Industry State Bank and Four County Auction Company. We hope to conclude around 6:30 p.m. The registration fee is \$15.00 at the door. You can pre-register by contacting the Extension Office or Sealy FFA Department by December 3rd. Credits to be given at the course include 1 hour of Laws and Regulations, 3 hours of General Credit and 1 hour of Integrated Pest Management (IPM).

Texas Animal Health Commission Announces Details of New Cattle Traceability Rule

A requirement for adult cattle in Texas to have an approved form of permanent identification in place at change of ownership will go into effect January 1, 2013 according to the Texas Animal Health Commission (TAHC). The Commission amended its rules in June of this year to enhance the effective traceability of beef cattle movements in Texas, which is the cornerstone of disease control activities. Implementation of the changes was delayed by the Commission to ensure cattle producers understand the requirements and can prepare for the changes.

The amended rule permanently cancels the brucellosis test requirement for adult cattle at change of ownership, which was unofficially suspended in the summer of 2011. Although testing of adult cattle is no longer required with the rule change, all sexually intact cattle, parturient or post parturient, or 18 months of age and older changing ownership must still be officially identified with Commission approved permanent identification. This change primarily affects beef cattle, as dairy cattle in Texas have had an even more stringent identification requirement in place since 2008.

Before August of 2011, official identification devices such as eartags were applied automatically at the time a brucellosis test was performed. The inadvertent loss of the identification devices applied to cattle when brucellosis testing stopped has threatened TAHC's ability to effectively trace cattle as part of any ongoing disease investigation.

The TAHC routinely performs cattle health investigations where the identification and location of exposed/infected animals is critical to success. For example, 30 Brucellosis reactors, over 300 Bovine Trichomoniasis affected bulls and 22 bovine tuberculosis cases have been investigated by the TAHC to date in 2012. The new traceability rule will help preserve the TAHC's ability to identify and trace animal movements quickly and effectively, no matter which disease is involved.

A complete list of acceptable identification devices/methods may be found at www.tahc.state.tx.us, but the most commonly used devices include USDA metal tags, brucellosis calfhood vaccination tags, US origin 840 series Radio Frequency Identification tags (RFID), and breed registration tattoos or firebrands. Producers are encouraged to contact their veterinarian or TAHC to determine which method of tagging will be best for their operation.

Free USDA metal tags, and a limited number of free applicator pliers are currently available and will be provided by the TAHC to producers wishing to use them. The tags and/or pliers may be obtained by contacting the Region 2 Office in Hempstead located at 1739 13th Street, suite 28. STATEWIDE REFERENDUM TO ESTABLISH A GRAIN INDEMNITY FUND FOR FARMERS

The Texas Grain Producers Indemnity Board is holding a referendum on the statewide establishment of a grain indemnity fund. The TGPIB referendum will be held from Nov. 19, 2012, until Dec. 7, 2012 across the state.

The grain indemnity fund board may award up to 90 percent of the financial losses suffered by producers of corn, sorghum, soybean and wheat when grain buyers fail to pay for grain due to a financial failure. The TGPIB was established as the result of legislation passed by the 2011 Texas legislature and signed into law by the governor. Rep. Larry Phillips of Sherman and Sen. Craig Estes of Wichita Falls introduced the legislation after a series of grain buyer financial failures in recent years resulted in millions of dollars in losses to Texas grain producers.

Eligible voters in the referendum will vote to establish an assessment rate within a range of 0.2 percent to 0.6 percent of the final sales price of grain. The assessment, which will be set each year by the TGPIB, will be collected and remitted to the TGPIB effective Feb. 1, 2013.

Any producer who has produced corn, sorghum, soybeans or wheat within the last 36 months is eligible to vote. This includes owners of farms on which grain is produced or an owner's tenant or sharecropper engaged in the business of producing grain or causing grain to be produced for commercial purposes.

The referendum will be held by mail ballot. Ballots will be available at all Texas A&M AgriLife Extension Service county offices during regular business hours.

For a ballot to be valid, it must be mailed to the Texas Department of Agriculture, P.O. Box 12847, Austin, Texas, 78711, with a postmark date of no later than Dec. 7, 2012.

Upon completion of their training, Master Gardeners will be required to give at least 50 hours of volunteer service time in their local community in order to receive the title of “*Master Gardener*”.

Multi County New Landowners Program starts in January 2013

Multi-County New Landowner Education program is a series of 10 informational meetings/seminars/field days designed to make new landowners in Austin Colorado, Fayette & Washington Counties aware of what types of agricultural enterprises are best for their property. Participants in the program will hear from experts in certain fields of agriculture about the best management practices that they can implement on their own property. This innovative program assists new landowners in understanding the concepts of rural living. Participants in the program are given exposure to ideas on raising livestock and horses, plant identification, fence building, applying pesticides, soil testing, stock pond management, pond construction, fruit and nut production, and much more. The program also serves as a way for new residents of the four counties to network and meet new people in their communities, find out what can be done on their land, what operations can be profitable, and possibly what opportunities they have to serve the community.

The program will be held on the third Friday of the months of January, February, March, April, May, June, August, September, October and November. Each month's meeting will be held at different locations in each county. The meetings begin at 1:30 p.m., and last about 4 hours. The first meeting for the 2013 series will take place on Friday, January 18th, at the Washington County Sales Facility. Cost is \$100.00 per person or \$150.00 per couple for all ten meetings or \$15.00 per person per individual meeting. CEU's for Pesticide Applicators will be given at each meeting, and refreshments will be served at each program session. Participants will receive a notebook full of timely and useful information. The Horticulture Committee of Austin County will be sponsoring a Small Farms and Vegetable Conference on Friday, February 22nd, 2012, at Cat Spring Ag Society Hall. Private Applicator Training and Testing March 27th

If you are planning on using a state limited use or state restricted use pesticide, such as Grazon P+D, 2 4-D, Weedmaster, etc... and need a license, the Extension Service will be sponsoring a Private Applicator Training and Testing on Wednesday, March 27th, at the Extension Office, 20 S. Holland in Bellville. The training will last from 8:30 a.m. until 12:30 p.m. A representative from the Texas Department of Agriculture will be on hand to administer the 100 question exam following the training. If you complete the training portion and then score a 70 or above on your examination, you will be eligible to apply for your Private Applicator License, which will allow you to purchase all state limited use and restricted use pesticides used in agriculture.

There is a \$50.00 fee to attend the training. Your registration fee includes the study materials and refreshments. You are strongly encouraged to pick up your materials early and read through them prior to coming to the training. To reserve your spot at the training, contact the Extension Office. Please bring something to write with and a calculator.

Here We Go Again!!! **Texas “A&M” AgriLife Extension Service**

Here’s a bit of trivia for those of you who have grown up around 4-H, county agents, or some other Extension programs, the question is “What was the original name given to the Extension Service here in Texas after the passage of the Smith-Lever Act in 1914 that set in motion the creation of what we know today as the Texas AgriLife Extension Service? If you said the “Texas Agricultural Extension Service” you would be correct! But in 2001, the Extension Administration decided our organization needed a face lift and our name was changed to Texas Cooperative Extension. There it remained until 2008 when a new Texas A&M president decided that we needed to have a stand alone brand and it was again changed to the Texas AgriLife Extension Service. Well, here we go again, our official name has now been changed by the Vice Chancellor’s office in an effort to brand all state agencies under the Texas A&M system with the A&M name, therefore our new name is the Texas A&M AgriLife Extension Service. This change not only affects our agency but also the Texas Forrest Service (now the Texas A&M Forrest Service), the Texas Transportation Institute (now the Texas A&M Transportation Institute), the Texas Veterinary Diagnostic Lab (now the Texas A&M Veterinary Diagnostic Lab), and several more entities under the Texas A&M System.

The good news is that the programs and services offered by the County Agents will not change. The mission of our agency is and will remain the same as its always has been, providing the best in the way of research based educational programs and information to the citizens of our great state. And just in case you get confused, you can still call the courthouse and ask for the county agents office and we’ll still answer.
