Five Hour CEU Conference **Friday, December 5th**

Renewal time for private pesticide applicators will be coming up shortly on February 28, 2014. As a reminder to anyone with a license, private applicators need 15 Continuing Education Units in order to re-certify. Two hours must be in Laws and Regulations and two hours must be in Integrated Pest Management, with the others coming in the General Category.

Anyone needing hours should mark **Friday, December 5th** on their calendar. On this day, the Beef and Forage Committee of Austin County, Austin County Farm Bureau and the Sealy FFA Chapter will be co-sponsoring a 5 hour CEU course at Four County Auction Center in Industry. Registration will take place at 12:00 p.m., with the program following about 1:00 p.m.

The program topics will include Pesticide Laws and Regulations, Water Impairments and Runoff Avoidance Issues, IPM for Pasture Pests, Weed in pastures and the new products for controlling brush. There will be no meal served as in years past, however refreshments will be served following the meeting compliments of Huff Brewing Company. We hope to conclude around 6:30 p.m. The registration fee is \$20.00 at the door. You can pre-register by going to our website <http://austin.agrilife.org> or by calling (979) 865-2072 by December 4th. Credits to be given at the course include 1 hour of Laws and Regulations, 3 hours of General Credit and 1 hour of Integrated Pest Management (IPM).

Private Applicator Training December 11th

If you are planning on using a state limited use or state restricted use pesticide, such as Grazon P+D, 2 4-D, Weedmaster, etc... and need a license, the Texas A&M AgriLife Extension Service of Austin County will be sponsoring a Private Applicator Training on Thursday, December 11th, at the Extension Office, located at 20 S. Holland in Bellville. The training will last from 8:30 a.m. until 12:00 p.m., and is a mandatory component in the process for acquiring a private applicator license. The Texas Department of Agriculture (TDA) no longer does testing at County Extension Offices, instead the tests are given at centers located at one of 22 regional testing centers across the state, four of which are in Houston. The Texas Department of Agriculture (TDA) has contracted with PSI Services (PSI) to administer exams for agricultural pesticide applicator licensing.

Upon completion of the training, potential applicators must first apply for a license with TDA. Go to the TDA website at: <https://texasagriculture.gov/LicensesRegistrations.aspx>. You may also call TDA at (800) 835-5832 or (512) 463-7622 for assistance. Upon approval from TDA, you will be sent an Examination Eligibility Letter, along with instructions for paying and scheduling the examination. Potential applicators are responsible for contacting PSI to pay and schedule for the examination. You may either schedule via the Internet at www.psiexams.com, or schedule over the telephone at (800) 733-9267.

There is a \$60.00 fee to attend the training. Your registration fee includes the study materials and refreshments. You can reserve your spot at the training by going to our website <http://austin.agrilife.org> or by calling (979) 865-2072 .

Texas Watershed Steward Workshop

A Texas Watershed Steward workshop on water quality issues related to Mill Creek will be held on January 9th, 2015, from 1:00 - 5:00 p.m. at the Courthouse basement meeting room in Bellville. The training is free and open to anyone interested in improving water quality in the region. Participants are encouraged to preregister at the Texas Watershed Steward website at <http://tws.tamu.edu>. The workshop is presented by the Texas A&M AgriLife Extension Service and the Texas State Soil and Water Conservation Board. Development of a Watershed Protection Plan for Mill Creek will soon begin, and involvement by local citizens is crucial during this process. Therefore, this training is designed to help watershed residents improve and protect their water resources by becoming informed and actively involved in their local watershed protection and management activities.

The workshop will include an overview of water quality and watershed management in Texas, with a focus on area water quality issues, including current efforts to help improve and protect Mill Creek. Though the workshop will address issues related to Mill Creek, the information provided will be applicable to all waters in the region. The training will include a discussion of watershed systems, types and sources of water pollution, and ways to improve and protect water quality. There also will be a group discussion on community-driven watershed protection and management.

Along with the training, participants receive a copy of the Texas Watershed Steward Handbook and a certificate of completion. The program offers four continuing education units in soil and water management for certified crop advisers, four units for professional engineers, professional geoscientists,

and certified planners, and four credits for certified teachers. It also offers three general continuing education units for Texas Department of Agriculture pesticide license holders, four for certified landscape architects and three for certified flood plain managers. Home Maintenance of Aerobic Septic Systems Training

The Texas A&M AgriLife Extension Service of Austin County will be sponsoring an Aerobic Septic Systems training for homeowners on Tuesday, January 13th, 2014, from 8:30 AM to 3:30 PM at the Extension Office in Bellville. A \$100 fee will be charged per participants, which includes lunch and teaching materials. The class is limited to the first 25 participants - Minimum 10 participants for the class to make. Directed to the homeowner, this session provides a basic training in proper evaluation of structures, equipment and operation of already installed aerobic septic systems in homes. A certificate of attendance will be provided upon the completion of the course.

The introduction to aerobic treatment units program provides homeowners with the knowledge about aerobic treatment of wastewater and the activities needed to maintain an onsite wastewater treatment system. The goal of the training is to provide a basic outline of operation and maintenance activities for an Aerobic Treatment Unit, make homeowners better consumers in the onsite wastewater treatment industry, and help homeowners develop a professional relationship with their maintenance provider.



Multi County New Landowners Program begins on January 16th, 2015

The Multi-County New Landowner Education program is a series of nine informational meetings/seminars/field days designed to make new landowners in Austin, Colorado, Fayette & Washington Counties aware of what types of agricultural enterprises are best for their property.

Participants in the program will hear from experts in certain fields of agriculture about the best management practices that they can implement on their own property. This innovative program assists new landowners in understanding the concepts of rural living.

Participants in the program are given exposure to ideas on raising livestock and horses, plant identification, fence building, applying pesticides, soil testing, stock pond management, pond construction, fruit and nut production, and much more. The program also serves as a way for new residents of the four counties to network and meet new people in their communities, find out what can be done on their land, what operations can be profitable, and possibly what opportunities they have to serve the community.



The program will be held on the third Friday of the months of January, February, March, April, May, August, September, October and November. Each month's meeting will be held at different locations in each county. The meetings begin at 1:30 p.m., and last about 4 hours. The first meeting for the 2014 series will take place on Friday, January 16th, at the Washington County Fairgrounds in Brenham. Cost is \$125.00 per person or \$200.00 per couple for all nine meetings or \$20.00 per person per individual meeting. CEU's for Pesticide Applicators will be given at each meeting, and refreshments will be served at each program session. Participants will receive a notebook full of timely and useful information. For anyone interested in participating in the Master Gardener training program, the deadline for signing up is Thursday, January 22nd. Participants need only come by the Extension Office to register. There is a fee of \$175.00 per participant, which will cover the cost of materials, and defray speaker expenses. The classes will be

held on Tuesdays mornings beginning on January 27, 2015.

The Master Gardener program is a unique opportunity for individuals who are interested in horticulture and serving their community. Master Gardeners are trained in all facets of horticulture such as plant & soil science, entomology, plant pathology, landscape design, vegetable gardening and much more. Upon completion of their training, Master Gardeners will be required to give at least 50 hours of volunteer service time in their local community in order to receive the title of "**Master Gardener**".
