1. **INDOOR BOOTH SPACE** (heat/air conditioned): Commercial Booths may be set up inside the Civic Center on Friday, December 6th from 3:00 PM - 6:00 PM. Late set-up will be Saturday, December 7th from 7:00 AM - 9:00 AM. Booths must be kept attractive and fit in space designated.

**No merchandise deemed obscene by management will be allowed**

Hours of operation will be Saturday, December 7th and Sunday, December 8th from 10:00 AM - 4:00 PM. **All booths must be open both days during these hours. Times are subject to change.**

2. **REFUNDS:** No refunds will be given after application is received.
3. The Coryell 4-H Holiday Market/Coryell County 4-H will not be liable for loss or damage caused by fire, theft, or vandalism.
4. **SOUND DEVICES:** No sound systems or broadcasting devices of any kind may be used without the approval of the event management.
5. **Compliance with laws-** lessee, his agents, employees or assignees shall comply with all rules, regulations and requirements of the Health Department, Fire Marshall, or any governmental entity having jurisdiction over the premises.
