Wildlife Ranches: The Good, The Bad, & The Ugly

Wildlife ranches are as diverse as livestock enterprises. There's whitetail, exotics, turkey, quail, and even hogs. Questions arise about nutrition, management, interaction between wildlife species or interaction with livestock, and so much more. Some ranches manage for exotics, but how should livestock ranches deal with them? Then there's the issue of feral hogs.

To that end, Texas A&M AgriLife Extension Service will be offering an educational program we're calling "Wildlife Ranches: The Good, The Bad, & The Ugly". It will be on October 28 at the Sutton County Civic Center. Registration is at 8:30 a.m. and the program begins at 9.
