# 2017 VENDOR AGREEMENT

## Rules and Regulations

*(Vendor keeps this page)*

Booths must be set up between 7:00 a.m. and 9:30 a.m. on Saturday, November 4. All vehicles must be moved to available parking outside of the sales area by 9:30 a.m. Alleys will not be obstructed by vehicles or booths. Any vehicle found inside sales perimeter will be subject to towing.

Vendor spaces are 12 ft. by 12 ft. The entire set-up, including trailer hitch, must fit within the designated space(s). Vendors must provide their own canopies, displays, tables and chairs. No stakes can be used in the set-up of booth. Booth fee is non-refundable, once approved.

No one will be allowed to dismantle booths until 4:00 p.m. Saturday. Vendor is responsible for all clean-up around booth. Trash receptacles will be available.

Electricity or any special request of vendor must be indicated on the vendor application. Vendors must bring own electrical cords to plug into city boxes. No generators allowed.

Vendors are responsible for the pleasant and safe presentation of their wares. Any and all hazards – such as extension cords, etc. – need to be secured to insure safety for all.

Frio Vision Alive reserves the right to deny entry of inappropriate booth or booth items and has sole authority for approval of booths or booth items. Officials reserve the right to remove any item deemed unapproved or unacceptable. Officials also reserve the right to limit the number of spaces of the same product.

All food service providers must wear gloves and hair nets when handling food.

All youth groups must have adult supervision within their booth at all times.

Vendors must comply with State Comptroller's requirements and are responsible for collection of Texas Sales Tax as well as any and all posting requirements.

Vendors must sell out of their assigned spaces only. No soliciting activity outside the booth space will be allowed.

Sale of firearms by vendors and participants is strictly prohibited.

No vendor shall sell any illegal item or items that infringe on registered trademarks.

All rentals must be handled through Frio Vision Alive. No vendor shall sublet their space.

Possession and sale of alcohol is prohibited.

Spaces are reserved only for business and marketing purposes, political booths will not be allowed.

***In order to participate in Frio County Market Day, vendors must agree to the following and sign on the front page:***

- Frio Vision Alive reserves the right to remove any vendor at any time for any violation of the rules. Any confrontation with another vendor or representative of Frio Vision Alive will result in the termination of your application and an immediate request to leave the premises.
- The vendor agrees to defend, indemnify, and hold harmless Frio Vision Alive, its officers, agents, and members from and against all liabilities, claims, suits, or demands for injuries to any person and/or property arising out of the undersigned's participation in such activity.
- The vendor agrees to assume all financial responsibility, including, but not limited to damages to property or injuries to persons, arising out of vendor's participation in Frio County Market Day.

*Vendors are encouraged to provide their own liability insurance. Vendors will be required to sign a liability waiver (in this document).*
