In 2011 the award was expanded allowing two awards to be given: Outstanding Boy Exhibitor and Outstanding Girl Exhibitor. This award is not based on animal performance or placing but on the senior's dedication, character, sportsmanship and skills learned by participation in the Stock Show and Country Store. You will be given a 15 minute interview, much like a job interview, giving you an opportunity to reflect on your experiences. An official committee will choose the winner.

Criteria for Selection:

SIGN UP FOR THIS AWARD BEFORE JANUARY 29, 2021 BY CONTACTING MARSHA GULICK AT 830-334-1286. THE EXHIBITOR WILL BE SCHEDULED A TIME TO BE INTERVIEWED BY THE COMMITTEE.

- 1) The recipient must be a graduating high school senior (12th grade)
- 2) The individual must be entered in the current year stock show or country store.
- 3) Academic grades will not be considered.
- 4) Other awards, animal placing or showmanship shall not be counted towards or against this prize. This award stands alone on its own merits.
- 5) The individual will be given credit if he/she completes the Quality Counts program.
- 6) The individual must demonstrate outstanding courtesy, helpfulness and support during the stock show or preparation for the stock show.
- 7) The name of the winner will not be announced until the presentation of the award.
- 8) The recipients of the award will be selected by a Committee selected by the Gulick Family.

Award:

- Trophy to be displayed by the top scoring winner for one year then returned to the extension office before the next year's stock show. Winner is responsible for adding names to the trophy
- Belt Buckle for each winner.
