The seminar also serves as an opportunity for attendees to network with others in the industry and support agriculture programs throughout the coastal bend.

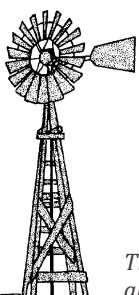
This year, the seminar will focus on regeneration of the soil, and visit soil

**AUGUST 1, 2018:** The Cactus moth has been observed in **Brazoria County, Texas.**



The prickly pear cactus — a rugged and at times cursed symbol of the American Southwest — continues to be threatened by a foreign pest that scientists fear will be much more difficult to contain with the state vast resources of the plant.

The pest, *Cactoblastis cactorum*, or the cactus moth, was discovered in Texas, which has hundreds of traps set up to lure any insects that may be around and dozens of volunteers looking for the pest on the cactus it consumes.

It has moved steadily north and west from the Florida Keys where it was first detected in 1989. It's been detected as far north as South Carolina and now as far west as Angelton.

Though there were quarantines in place regarding the movement of prickly pear plants from infected areas, officials are not surprised that this pest finding themselves in the lone star state where their hosts are much more plentiful and the space much more difficult to control.
