## MISS PHOTOGENIC

This is an optional category your child may enter. The additional cost to enter is \$25.00, but you will also receive a photo package with 1 - 5x7 and 4 - wallets. The pictures must be made by Deann Dickens of Picture It By D' Photography, 903-474-1170. You must call her by **Friday, August 10, 2018** to schedule your appointment and pay for it the day she takes the picture. The pictures will be taken on **Saturday, August 18, 2018** at Texas A&M AgriLife Extension Service office (Hwy 276, across from RYSA Ball Fields). They will be judged by the Pageant Judges the day of the interviews.

## REHEARSAL

**Monday, August 20, 2018 at 6:00 p.m.** at the fairgrounds. A parent or guardian **MUST** be at the practice. If you are not able to attend, please call and let me know.

## PAGEANT

**Thursday, September 13, 2018 at 6:00 p.m.**

An adult designated by the Pageant Chairman will walk with the contestant on stage. Parents will **NOT** be allowed backstage during the pageant.

## PARADE

**Saturday, September 15, 2018 at 10:30 a.m.** Line up at **9:30 a.m.** at the lot behind Alco. You can get to it from Honeysuckle Lane. The winner, first, and second runners-up will be in the parade. Furnish your own transportation and two signs on your car with your name and title. If you fail to participate in the parade, you risk being ineligible to participate in future pageants. If you can't be in the parade, it must be approved prior to the parade by your pageant chairman.

**NOTES**

Each contestant will be judged on personality, poise, beauty, posture, and apparel as suited to the individual and their age. All contestants must compete in all areas of the contest and must be able to represent the Fair Association and Rains County at various events throughout the year.
