QUALIFICATIONS

Contestant must be a full-time resident of Rains County and be within the correct age category (10-11 years) as of the date of the pageant.

DRESS CODE FOR PAGEANT

Short party dress, short pageant dress, or tea length dress. (Questions, please ask).

NOT CONFORMING TO THE DRESS CODE COULD CAUSE DISQUALIFICATION! Dress length will be left up to the judges' discretion.

DRESS CODE FOR PRELIMINARY JUDGING

Sportswear (Dressy Casual). The contestant will not be allowed to participate in the Preliminary Judging if she comes to the interview in her pageant dress.

This is an optional category your child may enter. The additional cost to enter is \$40.00, but you will also receive a photo package with 1 - 5x7 and 4 - wallets. The pictures will be taken on **Saturday, August 13, 2022** at her studio at 111 S. Texas Street (between Potts Feed Store and Potts Gas Company). They will be judged by the Pageant Judges the day of the interviews.

REHEARSAL

Thursday, September 8, 2022 at 6:45 p.m. at the fairgrounds. A parent or guardian **MUST** be at the practice.

NEW RULE: 10 points will be deducted from the contestant's overall score if she and her parent/guardian are not present at rehearsal. **NO EXCEPTIONS!**

PRELIMINARY JUDGING

Saturday, September 10, 2022 at the Rains Elementary School. Judging for this age group will begin at **2:30 p.m.** We will begin on time! If the contestant is not ready when the pageant chairman calls for her age group she could be disqualified.

PAGEANT

Thursday, September 15, 2022 at 7:30 p.m.

PARADE

Saturday, September 17, 2022 at 10:00 a.m. Line up at **9:00 a.m.** at the Emory City Center. The winner, first, and second runners-up will be in the parade. Furnish your own transportation and two signs on your car with your name and title. If you fail to participate in the parade, you risk being ineligible to participate in future pageants. If you can't be in the parade, it must be approved prior to the parade by your pageant chairman.

QUEEN

Saturday, September 17, 2022 at 6:30 p.m. Little Miss Rains County will help pass out water and snacks to the Rains County Fair Livestock Buyers. Wear your crown and banner and clothing appropriate for the livestock sale, i.e. jeans, nice shirt, and boots. The pageant chairman will supervise your child during this time.

QUEENS ARE NOT ALLOWED TO WEAR THEIR CROWN AND BANNER WHILE SELLING THEIR ANIMAL AT THE RAINS COUNTY FAIR LIVESTOCK SALE.

NOTES

Each contestant will be judged on personality, poise, beauty, posture, and apparel as suited to the individual and their age. All contestants must compete in all areas of the contest and must be able to represent the Fair Association and Rains County at various events throughout the year.
