The 2014 economic value of Walker Co Master Gardener's volunteer hours provided to support Extension education outreach in our county was \$151,665.66.

Ranch Management University

G. Rollie White Visitor's Center 7707 Raymond Stotzer Pkwy. College Station, TX 77845 March 30th (Monday) – April 3rd (Friday) Cost: \$500.00 per workshop attendee

The Ranch Management University is an <u>intensive 5-day event</u> targeting new or inexperienced ranchers and landowners and covers the fundamentals of soils and soil fertility, forage establishment, pasture management, and utilization by livestock. Basic livestock management practices such as castrating and vaccinating calves are demonstrated. Grazing management, stocking rate, and body condition scoring are also highlighted. Additionally, several wildlife management topics are covered for those interested in managing white-tailed deer, turkey, quail, feral hogs, and farm ponds.

Approximately one-half the workshop involves lectures and discussion, with the remainder consisting of the field demonstrations of various how to methods of soil sampling, planting, calibrating sprayers, and inoculating legume seed. Various forage species, including bermudagrass, small grains, annual ryegrass, and clovers are studied by workshop attendees. Additional demonstrations covers deer necropsy, hog trap management, and pond fisheries management.

Plenty of time is allowed for interaction with Texas A&M University faculty with expertise and experience in all management facets of the soil-plant-animal interface and wildlife management.

<u>Timber Management Plans/Meeting Requirements for Tax Appraisal Valuations</u>

This topic has been an item of discussion and landowner need for some time now. I am pleased to announce that The Texas A&M Forest Service (Montgomery, Harris, Waller & Walker, Grimes Counties)

has received authorization to provide training to landowners which will assist the landowner in writing your forest management goals (plan) for your property.

TRACE MINERAL SUPPLEMENTATION FOR BEEF COWS

A herd "in a production environment where forage and grazing was well managed but free-choice mineral supplementation was historically not practiced" was used in a research study. One-half of a herd of spring-calving cows was either injected or not injected on April 15 at the rate of 0.5 ml/100 lb body weight with a product containing the following:

- ∘60 mg/ml zinc
- ∘15 mg/ml copper
- ∘10 mg/ml manganese
- ∘5 mg/ml selenium

There was no difference in body weight at any time during the year-long study. Body Condition Score of injected cows tended to be higher when calves were worked, but not at weaning, calving, or rebreeding. Pregnancy rate, post-calving interval, and time from exposure to bull and subsequent breeding did not differ. NOTE: While trace mineral supplementation did not affect reproduction in this study, results could be different under different forage and management. As with all nutritional supplementation, optimum implementation should be tied to animal requirements and dietary composition.
