**AgriLife Extension Offers TDA-Mandated Trainings for
Dicamba-Tolerant Cotton Use**

The Texas Department of Agriculture is requiring special training in 2018 for new auxin herbicides applied under a Section 3 approval on dicamba-tolerant (Xtend Technology) cotton. To meet this requirement, the Texas A&M AgriLife Extension Service in Hockley, Cochran and Lamb counties have hosted several trainings and will host a training on:

The class will provide one TDA continuing education unit on laws and regulations.*

Current Cotton Crop Conditions

So, suffice it to say that I have seen much better starts to a growing season. I just wanted to alert producers to keep an eye on thrips. With all that is going on to just try to establish this years crop we can lose sight of what may be happening in those acres which are up and struggling because they may have thrips insects scratching their way through these young leaves. Most acres have a seed treatment which is holding against this thrips pressure, however, if you planted seed without any protection then you really need to look at those acres. Remember, one thrips per one true leaf is the threshold. A simple acephate application will help take pressure off for a few days. Given the temperature and irrigation to keep these plants moving. Growth will outpace thrips hopefully very soon. But keep an eye out until plants reach the 4-5 true leaf stage.

Always check labels for compatibility of products, especially the new auxin technology products.

Vydate C-LV is back in the marketplace. If you have heavy nematode pressure fields I would highly suggest you consider applying two applications 7 days apart starting at the 3-leaf stage at 8.5 oz broadcast rate per acre. If you can band it accurately you can save some money.

Private Pesticide Applicators Training 2018 Cochran, Hockley and Lamb Counties

The Texas A&M AgriLife Extension Service will offer the required private Pesticide Applicators Training (PAT) in Morton, Levelland and Littlefield throughout 2018. This training is required by Texas Department of Agriculture before taking the exam for obtaining the license. A private pesticide applicator is a person who uses or supervises the use of a restricted-use or state limited-use pesticide or a regulated herbicide for the purpose of producing an agricultural commodity. This license is not for those receiving monetary compensation for a pesticide application.

To participate in a training individuals must call 806-894-3159 by 3pm the day prior (Wednesday) to the trainings in Levelland; or 806-266-5215 by 3pm the day prior to any trainings in Morton. The trainings will begin promptly at 1pm at the Extension Offices (see addresses below). There is a \$60 fee for training materials. This is only the required training. Testing will be conducted at a separate time and location. Future PAT Trainings:
